HIGH RISK

On-site in response to pest activity. The surveyed facility areas include food preparation, storage, display areas, and outside grounds. Observed the following:

Rodent droppings observed inside or under:

- Broken walk-in cooler by the loading area
- Back storage area in the produce department
- Purposed new deli area
- Aisle 3 shelving
- Meat department tray storage shelf

Rodent droppings were observed on customer area shelves by the following items:

- Rice
- Lentils
- Pasta
- Prego
- Cheese curls
- Bread crumbs
- Chicken gravy
- Turkey gravy
- Chili
- Pork grind
- Chicken chow mein
- Soy sauce
- Pretzels
- Potato chips
- Bread

Dead mice observed:

- 11 dead mice in the proposed new deli area. Currently, a vacant space
- 1 dead mouse on a trap by the walk-in cooler

No evidence of current pest control company activity or recent treatments. Observed many abandoned traps from a previous pest control company.

Fly infestations around the compactor outside and by cardboard stack in the loading dock area.

The first double door to the facility is being kept open. Investigate

Corrective Action: Eliminate harborage area, food sources, and entry sites

Corrective Action: Clean and maintain
