Active roof leak onto a food prep counter, in the hallway leading to the walk-in cooler, in front of the

walk-in cooler, and in front of the dry storage.

Food Code Section(s): 331

**Corrective Action:** Discard/remove food that is not in sound condition or not from an approved source.

Violation: 14 Cleaning and Sanitization

Comments: \*LOW RISK\*

A food preparation counter near the walk-in cooler is wet from an active leak from the ceiling.

Food Code Section(s): 311

Corrective Action: Clean and sanitize food-contact surfaces of equipment and utensils after each use and following

any interruption of operations, during which time, contamination may have occured utilizing the

following procedure:

1. Wash- hot soapy water.

2. Rinse-clear water.

3. Sanitize-approved sanitizer and water.

4. Air-dry.

Corrective Action: Disinfect all counter tops, and equipment that has been affected by the roof leak.

Violation: 23 Contamination Prevention - Food, Utensils and Equipment

Comments: \*LOW RISK\*

Active leak in front of and possibly onto dry storage items.

Food Code Section(s): 331

Corrective Action: Protect Food

Corrective Action: Monitor

Corrective Action: Discard any food that shows signs of being adulterated from the leaking roof.

Violation: 27 Floors

Comments: \*LOW RISK\*

Floors in critical areas (in front of food preparation area, in front of the walk-in cooler, and in front of

the dry storage) has water from the leaking ceiling.

\*LOW RISK\*

The floor under the leak area has diamond plating that is peeling up and chipping in places. It also

has brown substance underneath and its spreading out from underneath.

Food Code Section(s): 312

Corrective Action: Clean and maintain

**Corrective Action:** Disinfect the floor under the active leak.
