**Violation:** 1 Food Source/Condition

**Comments:** \*HIGH RISK\*\*\*  
Water from an unknown source (possible roof leak) in critical areas with the potential to contaminate food and food contact surfaces. Water observed dripping from the return air vents of the ventilation system over the cooking line. There are two areas: In front of the large noodle cooking station, and in front of the steamer.

**Food Code Section(s):** 331

**Corrective Action:**  
- Discontinue preparing food until roof leak is repaired.  
- Investigate potential roof leak, make repairs as needed.

**Violation:** 27 Floors

**Comments:** \*LOW RISK\*  
Floor under the cook line has a large build-up of grease. During the inspection, the employees started to clean the area.

**Food Code Section(s):** 312

**Corrective Action:** Clean and maintain

**Violation:** 28 Walls and ceilings

**Comments:** \*LOW RISK\*  
Shelf above the entire service line and opposite from the cook line has dust and grease build-up and is hanging down.

**Food Code Section(s):** 312

**Corrective Action:** Clean and maintain

**Violation:** 29 Lighting

**Comments:** \*LOW RISK\*  
Light shield in the ware washing area is held up with tape.

**Food Code Section(s):** 314

**Corrective Action:** Provide adequate shielded lighting

**Violation:** 30 Ventilation

**Comments:** \*LOW RISK\*  
Filters along the hood have a build-up of grease.  
  
The sealant behind the hood, against the back wall, is missing in places and falling down in other areas.

**Food Code Section(s):** 313

**Corrective Action:** Clean and maintain
