**EMERGENCY**

-Active sewage backup in the facility. Sewage observed backing up from floor drain in women's toilet room, floor drain between toilet rooms beneath water fountains, and waste water was observed on the floor of the men's toilet room originating beneath the toilet. Floor drains next to the mop sink and in the women's toilet room appear to be full of water. A strong sewage odor accompanies the waste water emerging from floor drains.

Employee stated backups were first observed approximately one week prior occurred at floor drains throughout the store when toilets were flushed or water was run at any fixture, including the mop sink in the rear of the store.

\*MEDIUM RISK\*\*

-No operable toilets. Toilet in men's room did not flush. Toilet in women's toilet room flushed but then caused sewage to backup from multiple floor drains.
